#### i. Mason County Life vs Other Communication Options

(Possible Action)

Currently, per Dennis Williams, Director of Circulation Sales of the Kitsap Sun, they print 9,259 copies of the Mason County Life each week. He stated that the Mason County Life is direct mailed to all addresses in Shelton's 98584 zip code, but according to the USPS there are 15,623 addresses within 98584, so they are not saturating the area. He stated that there are no direct mailings to addresses in the North Mason area, but that the paper is available for pickup at various locations in Belfair and Allyn. That means people have to seek out their copies if they can find any. NMSD costs = \$1,000/month, \$12,000/annual. When NMSD first began advertising in the MC Life, circulation was much larger, especially in the North Mason area, but over the years it has gradually diminished.

The administration recommends that the Board of Directors...

... discontinue monthly letters in Mason County Life and instead publish a newsletter that is direct mailed to 98528, 98524, 98588, select routes in 98546 and 98312.
