5. Elementary Configuration and School Start Times Advisory Committee (Action)

Superintendent Rosenbach gathered a group of parents and staff to participate on her advisory committee to analyze the possibility of changing school start times and a resolution to the over-crowding at Belfair Elementary. The committee has concluded that a short-term plan for moving the boundary line for attendance at Sand Hill and Belfair Elementary would be most beneficial and disrupt less families. Sand Hill could make room for 2 or 3 classrooms so the boundary change recommended by the transportation department that would affect approximately 50 students would resolve the problem. Changing school start times has not been recommended at this time.
