LOCAL INFORMATION PROVIDED BY YOUR DISTRICT

Important: The data is a report on the 2016-17 school year, which is two (2) school years ago. This is the most recent data from Oregon Department of Education (ODE). The number of students at North Marion that receive special education services is about 300 total students, or about 15 % of total student population.

Our graduation rates are about 10% lower than the state target, which represents approximately two (2) students less than the state target. Our dropout rate is statistically one (1) student less than the target. The rates for least restrictive environment is overall better than the state target. This tells us that North Marion has a success of including students in regular education classes. Academic achievement scores our students with an Individual Education Plan (IEP) are representative of their peers in general education classes. We recognize that our students need to improve in math. Our rate of students enrolled in higher education or working competitively are at the overall state target. North Marion does has a normal discrepancy of discipline and/or suspension based on race or ethnicity. North Marion also has normal percentage of students identified for specialized services, based race or ethnicity. Both of these statements tells that we are NOT discriminatory in our professional practices.

Students in Special Education have goals for outcomes after graduation. The number of students measured in that category are too small to be reported.

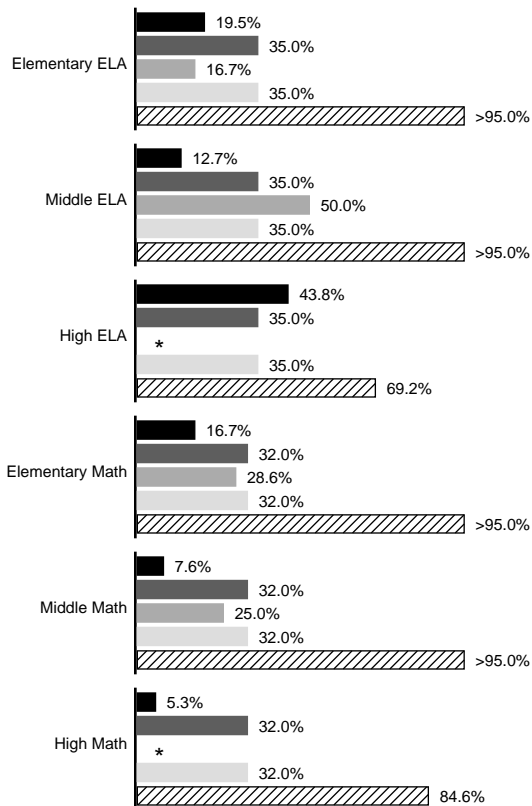
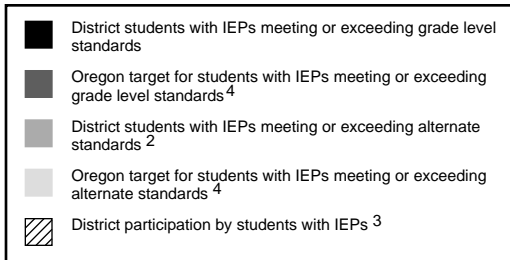
