#### Superintendent Report

Superintendent Kevin Acuff shared with the Board that there were 20 applicants for the Middle School Assistant Principal position and that the quality and number of applicants for openings has increased. They will interview 5 applicants. He referred the roof project to Jeff Monroe during his report. Superintendent Acuff discussed changing the current job position of Community/Parent Coordinator to include emergency communications and social media and asked the Board for input. He will be sharing an updated job description with the Board. He also shared that the Elementary received an award for Closing Gaps last week and would like a picture of the Board with the banner.

## **Facilities Report**

Facilities/Maintenance Supervisor Jeff Monroe shared that the High School roof project should be out to bid soon. The quote is for \$441,500. He also shared the options for power hookup at the new Elementary portable site with a hopeful completion by the beginning of school. The maintenance staff will be painting 10 - 12 classrooms and the middle school gym this summer. The classeteria asbestos inspection came back with asbestos only in the bathrooms. They are waiting on demolition because they still need to find a location for the Print Shop and move fiber.
