- Speakers will be provided five (5) minutes for their public comment.
- The total time allocated for public comment will be 30 minutes.
- If time permits, speakers who live outside of the West Valley School District will be called in the order that they signed-in (in-person) or used the "hand raise" icon (via Zoom).
