The purpose of tonight's meeting is to present the preliminary schematic designs. Rob Gross, Construction Manager, presented the Project Schedule, Matt Whitish, Design West Architect, provided three preliminary conceptual site plan options, and David Beaudine from CBRE Heery described the General Contractor/Construction Manager (GC/CM) delivery process for this project. The plans were projected on individual video screens for visitors to have a closer view of each plan. Forms were provided for patrons to submit their input/feedback and ask their questions.
