### MEMBERS OF THE PUBLIC WISHING TO ADDRESS THE BOARD

School board members welcome public comment. Board members will not respond to public comments during the meeting. The Superintendent or designee will follow up with you after the meeting if action is needed. Instead of providing public comment at a meeting, you may also email the Board at [board@tacoma.k12.wa.us](mailto:board@tacoma.k12.wa.us). Please contact the Board Office in advance of the meeting for accommodations.

#### OPTION 1: VERBAL COMMENT

For verbal comment, submit a "Citizen's Request to Speak" card before the meeting start.

- o The General Counsel will call your name when it is your turn to address the school board. Please speak into the microphone and state your name.
- o You may have up to three (3) minutes to share your comments or, if there are a large number of speakers, time may be limited at the President's discretion.
- o Additional time may be granted for accommodation (e.g., disability, language)

#### OPTION 2: WRITTEN COMMENT

For written comment, you may prepare a statement that will be attached to the board agenda and meeting minutes.

- o Send an email with the subject line "For Public Comment" to [board@tacoma.k12.wa.us](mailto:board@tacoma.k12.wa.us) at least 24 hours before the start of the meeting. Statements submitted after the deadline will not be considered at this session.

- o Because this will be a public document, we recommend you prepare the statement in a separate document using an application such as Microsoft Word. At the top of the document, please identify yourself and the subject matter (title). Please do not include your phone number, address, or email address unless you want that personal identifying information included in the public record.
- o Typically, the board allows up to three (3) minutes for verbal comments. A three-minute verbal statement converts to approximately 300-500 words or up to 2 pages double-spaced. Please limit your written statement to this guideline.
- o During the meeting, the General Counsel will read your name and the subject matter (title) of your statement into the record. They will not read your statement aloud during the meeting. Your statement will, however, be linked to the agenda so that members of the public may read it. It will also be linked to the meeting minutes for future reference.
- o Members of the board will review your written statement

## **ACCOMMODATION**
